

## EADA SCHOLARSHIP APPLICATION

EADA awards scholarships to outstanding candidates who demonstrate the potential for superior performance in the programme. Scholarships are merit-based and cover 25% of the programme fee (with exception of the Scholarship for Excellence, which covers up to 50%).

### Eligibility

---

Scholarship applications are available to all candidates who have successfully completed the admission process and paid 25% of the total fee of the programme.

### Deadlines

---

There are several scholarship deadlines each year. We recommend applying to the earliest deadline possible.

The required documentation must be received by post before the deadline.

<b>Masters</b>	<b>1st deadline:</b> March 31, 2018	<b>2nd deadline:</b> May 31, 2018	<b>3rd deadline:</b> July 31, 2018
<b>MBA</b>	<b>1st deadline:</b> 15 April 2018	<b>2nd deadline:</b> 15 July 2018	

### Results

---

EADA will notify candidates of the results via e-mail within one month of the corresponding deadline.

### Obligations of scholarship recipients

---

All scholarship recipients commit themselves to participating in the programme with a high level of dedication and excellence. Additionally, scholarship recipients are required to carry out an academic or administrative project while at EADA. This project can be assigned at any time during the academic year to which the scholarship has been applied, and recipients who chose not to do the project will be required to return the full amount of the scholarship. In submitting the application, candidates agree to the terms and conditions described here.

### Payment of scholarship

---

EADA scholarships and discounts do not stack; candidates who receive multiple awards will automatically be awarded the scholarship or discount with the highest value. All scholarships will be applied to the final payments of the programme.

### Special cancellation conditions

---

Special enrolment cancellation conditions apply to scholarship applicants. Unsuccessful scholarship applicants who cancel their enrolment within 10 working days of not being awarded the scholarship will be refunded all the payment(s) made towards the programme minus an administrative fee of 300€. After 10 working days, the normal cancellation conditions will apply.

- 2. Prepare the following documentation:**
  - Scholarship Application Coversheet (page 3 of this document)
  - Scholarship Awardee Contract (page 4 of this document)
  - A copy of the admission letter issued by EADA
  - A copy of the formal enrolment paperwork (and receipt) issued by EADA
  - A letter introducing yourself and explaining why you are an outstanding candidate for the scholarship. *This letter must be written in the language of the chosen programme.*
  - A letter of recommendation from your professional or academic background. *This recommendation must be written by someone other than the two references used during the admission process.*
  - A list of other activities that you are involved in such as student associations, professional forums, sports, etc. (when applicable)
  - *Additional documentation for the Scholarship for Excellence only:* A GMAT score of 700 or higher or documents demonstrating academic/professional excellence.
  - *Additional documentation for the Future Entrepreneurs Scholarship only:* A 350-500 word description of the entrepreneurship project that you hope to launch after graduation.

## SCHOLARSHIP AWARDEE CONTRACT

All scholarship candidates must sign this document describing the rights and duties of scholarship awardees. Signing this document means that you agree to these conditions in the case that you are awarded a scholarship.

### Duties of scholarship recipients

---

- Scholarship recipients are required to perform well in the programme, and to perform assigned duties at a high standard.
- Scholarship recipients are required to carry out an academic or administrative project while at EADA. This project may be assigned at any time during the academic year (Sept. – July) to which the scholarship has been applied. Projects will not be assigned before the programme begins.
- Candidates must submit a detailed description of their previous experience and profile, which will be used to assign projects. This summary will be requested at a later date via email.

### Rights of scholarship recipients

---

- Scholarship recipients have the right to receive the full amount of the corresponding scholarship awarded in the form of a discount applied to the total programme fee. All scholarships will be applied to the final pending payment(s) of the programme. EADA scholarships and discounts do not stack; candidates who receive multiple awards will be automatically awarded the scholarship or discount with the highest value.
- Scholarship recipients have the right to reject the scholarship project assigned to them. In this case, they will be required to return the full amount of the scholarship to EADA business school via credit card or bank transfer. Failure to do so will result in a delay in receiving the diploma.

### Non-Disclosure Agreement

---

The scholarship awardee will exert reasonable efforts to maintain disclosure of all of the information contained in this document, including but not limited to, the amount of the scholarship and the project assigned, in confidence, except in certain cases in which EADA Business School permits disclosure of the project details to faculty, alumni, associated companies or current students.
